## **LGBT Hate Crime on the Rise: 8% Nationwide & 10% in Chicago**

**Center on Halsted Releases Annual Report on Anti-lgbt Hate Violence Crimes** Center on Halsted's Anti-Violence Project (AVP) in conjunction with the National Coalition of Anti-Violence Programs (NCAVP) reported a disturbing 8% increase in anti-LGBT violence and hate crime. Chicago Police reported a 10% increase in such hate crimes. The total number of victims nationwide also increased, rising from 2,042 in 2003 to 2,131 in 2004. In Chicago, numbers of victims rose 16% from 56 in 2003 to 65 in 2004. The number of female victims in Chicago increased 100% from 13 to 26 while male victims declined slightly and the number of transgender victims remained the same. The Chicago Police also reported a 10% increase in anti-LGBT violent crimes.

Perhaps most disturbing is the 11% increase across the country in anti-LGBT murders, which rose from 18 in 2003 to 20 in 2004. Four of those reported murders took place in Chicago and included a seventeen-year old African American transgender woman and her friend, aged eighteen and the mother of a two-month old. Suspects in the case have been captured and charged with shooting the victims and leaving them burning in their vehicle.

The other two Chicago murder cases were of gay men Charles Gibson, aged 54, and Kevin Clewer, aged 31. Whereas Gibson's perpetrator has been apprehended, Clewer's case remains unsolved. After reading the report, Clewer's brother Ron Clewer stated, "In looking at this year's report with all of these numbers, it was hard to see Kevin reduced to a statistic. If there is one thing that I hope that comes out of Kevin's murder and this report it's that people will recognize that behind each of these numbers, is a face and a person, a human being; and behind that human being are family and

friends who are left to mourn the loss of their loved one. My family's hope is that we will be a part of the change to end violence so no other family has to experience what we are going through now."

Clarence Patton, NCVAP's Acting Executive Director said: "In the last edition of this report it became all too clear that with respect to violence, the nation's LGBT communities had entered a very new, and very dangerous year in which all of us were under attack at levels not seen in recent years. This year's report has to be viewed as a follow-up to our report from a year ago." This report examines data compiled from almost 2,000 hate-related incidents in eleven states, cities and regions (Chicago, Cleveland, Columbus, Colorado, Houston, Massachusetts, Michigan, Minnesota, New York, Pennsylvania and the San Francisco Bay area). Additional information was included regarding Kansas City, St. Louis, Tucson, and Vermont. This was NCVAP's most complete examination of violence against LGBT people.
